

ORDINANCE NO. OF 2019

BY THE CADDO PARISH COMMISSION:

AN ORDINANCE AMENDING THE BUDGET OF ESTIMATED REVENUES AND EXPENDITURES FOR THE GENERAL FUND AND THE CAPITAL OUTLAY FUND IN THE AMOUNT OF \$45,000 TO PROVIDE AN APPROPRIATION FOR A COSMETOLOGY PROGRAM AT THE RE-ENTRY FACILITY AT CCC AND TO OTHERWISE PROVIDE WITH RESPECT THERETO

WHEREAS, there are limited opportunities for female inmates housed at the Caddo Correctional Center (CCC) to advance their lives through career opportunities; and

WHEREAS, vocational programs within the prison system are common for men, the options for female prisoners are sparse; and

WHEREAS, the Cosmetology Program would take place at the re-entry facility at CCC and would allow incarcerated women to learn a new skill that would allow them to become licensed cosmetologists; and

WHEREAS, the Cosmetology Program will allow women inmates to learn about hair, nails, and basic aesthetics; and

WHEREAS the Cosmetology Program would allow incarcerated women to be able to support themselves after their release without turning to illegal activity; and

WHEREAS, the Cosmetology Program is intended to reduce recidivism by giving women an equal opportunity to have training that will prepare them to become viable citizens and provide for their families; and

WHEREAS, the Cosmetology Program requires assistance to purchase equipment and other supplies necessary to provide the cosmetology training including hair dryers, wash stations, and stylist booths; and

NOW, THEREFORE, BE IT ORDAINED, by the Caddo Parish Commission in due, legal and regular session convened, that Budget of Estimated Revenues and Expenditures for the General Fund and the Capital Outlay Fund for the year 2019 are hereby amended as follows:

BE IT FURTHER ORDAINED, that this ordinance shall take effect upon adoption.

BE IT FURTHER ORDAINED, that all ordinances or parts thereof in conflict herewith are hereby repealed.
