Please accept this letter as a courtesy correspondence that one of the Caddo Parish Commission's appointments to the Caddo-Bossier Parishes Port Commission's Board of Commissioners is scheduled to expire June 30, 2019. This appointment is currently held by Commissioner Erica R. Bryant.
