The general scope of the Project is as follows:

The project will include the reconstruction and general improvements to Mayo Road, beginning at the intersection with Linwood Ave. and ending at the intersection of Wallace Lake Rd. The Project consists of installation of additional cross drains, extensions of existing cross drains, replacement of existing side drains, select fill, drainage excavation, lime treatment, class II base course, asphaltic concrete binder and wearing courses, signage and other incidentals necessary to complete the project as required by the plans and specifications.

A full set of Contract Documents may be procured upon payment of \$75.00 per set, to be refunded to actual bidders upon return of the documents in good condition no later than 10 days after receipt of bids. One-half of all other deposits may be refunded to all others that return the documents in good condition no later than 10 days after receipt of bids.

Documents may be examined, without charge, upon request.

All bids must be accompanied by Bid security equal to five percent (5%) of the sum of the base Bid and all alternates and must be in the form of a certified check, cashier's check, or Bid Bond written in conformance with state law.

The successful Bidder shall be required to furnish a Performance, Maintenance, and Payment Bond on a form provided by the Parish and written in accordance with state law.

Bids shall be accepted from Contractors who are appropriately licensed under LA. R.S. 37:2150-2164.

No Bid may be withdrawn for a period of thirty (30) days after receipt of Bids, except under the provisions of LA. R.S. 38:2214.

The Parish of Caddo reserves the right to reject any and all Bids for just cause and to waive any informalities and technicalities. The Parish of Caddo shall incur no obligation to the Contractor until the Contract Between Owner and Contractor is fully executed.
